# Who can earn rewards?

- \* ANYONE who is 18yrs or older.
- \* Participants do not have to be St Peter's parishioners or a St Peter's School family.



# How do I earn rewards?

- \* ALL participants must review and complete the STP Reward\$ Participation Agreement.

## STP REWARDS PROGRAM AGREEMENT

St Peter's School PTA (referred to herein as "we," "us" and "our") sponsors a SCRIP card purchasing program which allows you to raise funds and earn credit toward your school account (comprehensive fees and before/after school care fees only) and/or gift some or all of the funds you raise to St. Peter's Social Services and/or St. Peter's General Fund and/or a different school family. Funds raised **may not** be applied to your **TITHE** due to rules and regulations that govern tithes.

Rebates earned which are credited toward a school account for tuition, comprehensive registration fees or before/after school care fees **are not** considered charitable contributions. Rebates earned which are donated to STP Social Services and/or STP General Fund **are** considered charitable contributions. We will provide you with all required acknowledgements of contributions under section 170(f)(8) and 170(f)(17) of the Internal Revenue Code.

To cover shipping, merchant account fees, bank service fees, software leasing/access fees, marketing and any administrative expenses incurred, our program will retain 3% of **total order amount**. The balance of funds rebates will be applied as you indicate below. No fees are retained by the PTA for any reason other than program and all labor is by PTA volunteers.

# Option #2: Order and Presto Pay

- \* Once you have set up your account on [shopwithscrip.com](http://shopwithscrip.com) (STP ID #L5114L5D12365)
- \* You can set up your PrestoPay Account
  - \* This will need some help from STP Reward\$ Coordinator
- \* Once set up, you can order and pay with PrestoPay . Orders will be placed on Mondays and the cards will be delivered the next Friday.



# How to set up PrestoPay

- \* Simply sign in to your account and follow the instructions on the PrestoPay link.
- \* Additional Options that are available with PrestoPay include:

# Option # 3: Credit Card Option

- \* STP Reward\$ is offering a unique opportunity to STP Reward\$ member to pay with your credit card.
- \* We will have this option available at all our cash and carry events (Back to school and Christmas)

# What If I Earn More Rebates Than I Need This Year?

- \* Rebates will be applied to the next year's comprehensive fees and before/after school care fees.
- \* They will roll forward; however, we do ask that you try to use up all of your credits prior to graduating from St Peter's School.



# Are The Rebates Earned Tax Deductible?

- \* Yes and No.
  - \* Rebates distributed to STP Social Services or STP General Fund ARE tax deductible.
  - \* Rebates applied as credits to your tuition, comprehensive fee and/or before/after school care fees ARE NOT tax deductible.
