

## **STP Reward\$ FAQs**

### **Who can earn credits?**

ANYONE who is 18yrs or older. Grandparents, Aunts, Uncles, Cousins, Godparents, Neighbors, Colleagues – really, anyone can participate. Participants do not have to be St Peter’s parishioners or a St Peter’s School family.

### **How do I earn credits?**

ALL participants must review and complete the STP Reward\$ Participation Agreement.

Buy cards and earn your credits! Here are your ordering options:

- **www.ShopWithScrip.com** - You can create your order on the site and submit a check via STP Reward\$ secure mailbox located in school lobby or pay with PrestoPay. Check payments must be received by 4pm on Fridays and online orders must be received by 4pm Sundays to ensure delivery the following week.
- **St Peter’s online store** accepts all major credit /debit cards for payment including ScripNow! and MyScripWallet items! If you purchase these through our online store – <https://squareup.com/market/stp-reward> - your purchases will not be available within minutes. These purchases will update Wednesday and Sunday evenings and will be available no later than Thursday and Monday mornings. Online orders must be received by 4pm Sundays for delivery the following week.
- **Via MyScripWallet** mobile application accepts PrestoPay for payment on your Android or iPhone. Purchases made on your mobile device using PrestoPay will be updated within a few minutes.
- **Via Written Order Form** deposited in STP Reward\$ secure mailbox located in school lobby – NO CASH IS ACCEPTED, Checks only.
- Stop by our monthly 3<sup>rd</sup> Weekend Sale and select from a limited inventory of local vendors on hand or purchase items to be delivered the following week. All major credit, debit cards and checks accepted.

Orders must be placed online or via written Order Form. Credits can only be earned for purchases made with a completed written Order Form including check or an online order. You must also have a completed STP Reward\$ Agreement on file. We cannot verify accurately what was purchased or how it should be credited if we do not have this information.

### **How Much Can I Earn?**

As much as you like! You receive credit for 100% of the **rebates you earn**, not the total dollars you spend, less an administrative fee of 3% of the **total order amount**. The administrative fee is retained by STP Reward\$ to cover shipping fees, bank service fees, merchant account fees, software access/leasing fees, marketing materials and other non-labor related overhead charges incurred.

Please use our STP Reward\$ Calculator to determine how much you will earn on any single order or recurring order. The STP Reward\$ Calculator is in Excel format and is available to download on the STP Reward\$ Facebook page, STP School and STP Parish websites.

### ***Who Else Benefits?***

Participants may designate how they wish their rebates earned to be applied when they complete the STP Reward\$ Participation Agreement.

Eligible beneficiaries are:

- Your school family
- Another school family or families
- STP Social Services
- STP General Fund

Participants may allocate distribution of their rebates earned to any or all of these beneficiaries.

### ***What Can I Buy?***

You name it, you can buy it! Disney vacations, groceries, clothes for the kids, meals out, gas for the car, new fishing pole for Dad, skin care for Mom and more and more.

Complete listings in .pdf form of all available cards are available on the ShopWithScrip website, the STP School and STP Parish websites as well as the STP Reward\$ Facebook page. One list is by category and the other is alphabetical by vendor name.

### ***Are The Rebates Earned Tax Deductible?***

Yes and No. Any credits you earn that are distributed to STP Social Services or STP General Fund **ARE** tax deductible and STP Reward\$ will provide you with all required IRS documentation of your contributions.

Any rebates you earn that are applied as credits to your comprehensive fee(s) and/or before/after school care fees and tuition if you are a tuition family **ARE NOT** tax deductible. These are considered to be payment of expenses and not charitable contributions.

### ***Are The Rebates Earned Considered Taxable Income?***

**NO!** Because there is no “selling” of the scrip cards by participants to raise funds or earn rebates, the proceeds are not considered income to any participant. There is an IRS Ruling Letter and a copy will be provided to you upon your request. Please email [patriotscrip@yahoo.com](mailto:patriotscrip@yahoo.com) and put IRS Letter in the subject line.

### ***What If I Earn More Rebates Than I Need This Year?***

We hope you will and those credits will be applied to your comprehensive fee(s), before/after school care fees and tuition if you are a tuition family. We are not able to apply credits toward your Tithe due to rules and regulations covering tithes. Your credits will roll forward; however, we do ask that you try to use up all of your credits prior to graduating from St Peter’s School.

### ***What If I Move or Leave St Peter’s School?***

You may cancel your participation in the STP Reward\$ program at any time with 60 day written notice to the STP Reward\$ Treasurer. The credits you have earned less the administrative fees charged will be paid to you via check within 30 days of your official date of cancellation, the 60<sup>th</sup> day from the date of your written notice.
